

Sample In-Service Proposal

This contract must be received in our office, with a 50% deposit amount, prior to (Date) in order to confirm. Final balance due 60 days prior to course.

Facility's Responsibilities:

- 1) Meeting Space
- 2) Audio/Visual Equipment (as requested by clinician)
- 3) Breaks (Coffee and Muffins in the AM, Refresh Coffee Mid-AM and a Soda Break in Afternoon)
- 4) Provide transportation for all NES staff members between airport-hotel-facility for the duration of the course. (A flight itinerary will be provided prior to the seminar)
- 5) Provide NES with the following information along with signed contract.
 - a) List of alternate lunch locations
 - b) List of sleeping accommodations for participants and staff at a local hotel
 - c) Exact shipping address for course materials to arrive at facility prior to course
 - d) Maps and directions to course location to be sent to participants to avoid phone calls prior to course
- 6) Provide Northeast Seminars with the <u>names</u>, <u>address and credentials</u> of the course participants 30 days prior to the course for processing of registrations and certificates.
- 7) Facilitator (Name and contact information needs to be provided along with list of staff (30) days prior to seminar), (detailed instructions to be faxed once name and contact information has been provided)
